### WE BUILT CIVIC AGENCY


From civic education to civic action, Street Law's work spanned schools, communities, and government agencies across the United States and around the world.

### This year we:

- Provided professional development to thousands of educators, equipping them with curricular materials and strategies for delivering civic and law-related education through interactive teaching methods.
- Authored the new edition of McGraw Hill Education's high school-level U.S. Government textbook. Each year this text reaches an estimated 1.5 million high school students across the United States.
- Created the curriculum for new Community Leadership Academies that will build leadership and advocacy skills for Kosovar youth

# WE ADVANCED EQUITY AND JUSTICE

Street Law's community-centered programs and tailored curricula worked to empower people who are vulnerable to injustice with essential knowledge and applicable skills to navigate law-saturated societies.

### This year we:

- Grew our Legal Diversity Pipeline Program. We added new program sites and mobilized nearly 800 volunteers to teach and inspire diverse high school students who are often underrepresented in the legal profession.
- Expanded our Legal Life Skills Program into additional communities and a new country, teaching young people and adults vulnerable to racism and injustice about their legal rights and responsibilities.
- Increased equity for individuals seeking legal justice in Pakistan by institutionalizing alternative dispute resolution (ADR) methods within law faculties in Sindh province.



## WE BUILT BRIDGES ACROSS DIFFERENCES

Street Law cultivated the skills that help people grapple with contentious issues through proven methodologies and interscholastic and intercultural exchanges.

### This year we:

- Launched a statewide project in Maryland to prepare elementary, middle, and high school teachers to discuss contested issues in their classrooms using Street Law methodologies. This project will later expand to all 24 Maryland school districts, reaching more than 400 teachers and 36,000 students.
- **Expanded our Deliberations curricular offerings,** providing new topical guides to facilitate cooperative and respectful discussions in classrooms and communities.
- Trained Maryland school resource officers to implement our Police & Teens program across the state. Our training prepared officers to teach lessons and to engage in exploratory dialogue that builds empathy, awareness, and trust between students and officers and uplifts the voices of young people.

# WE FOSTERED DEMOCRATIC CULTURE

Street Law's programs empower the next generation to become critical thinkers on issues of rule of law, democracy, equity, and justice.

### This year we:

- Deepened our work in Uzbekistan. We prepared law students and community activists in each region of the country to teach high school students and adults lessons on rule of law, democratic values, human rights, and legal life skills.
- Continued to strengthen rule of law education in Jordan through training and curriculum for youth center leaders, university professors, government officials, and community leaders.
- Developed the Rule of Law for All curriculum for use in U.S. classrooms. These new lessons will help students understand rule of law concepts, analyze rule of law in the United States, and process how people from different backgrounds experience rule of law differently.




